- a. Blank course registration form is provided.
- b. The Students need to consult with the respective Faculty coordinator and accordingly fill the detailed subject opted/eligible to register for this semester.
- c. Other personal details along with payment information need to be filled and send the same to the respective faculty advisor.
- d. A student can register for two backlog courses with a maximum of 8 (New regulations) /16 (Old regulations) additional credits along with the regular semester courses without dropping any course. In such case, S/he has to pay additional fee of **Rs. 12,500/-** (Rupees twelve thousand five hundred only) for each course apart from the regular semester fee.
